# PhD students in the spotlight

PhD students are a vital part of the research community, and the Research Network on Ageing in Europe is dedicated to supporting them. During the last months, we therefore initiated two projects. First, we installed two representatives of the PhD students in our Research Network. These representatives are Daniela Craveiro from the University of Minho, Portugal, and Edward Tolhurst from Staffordshire University, United Kingdom. Craveiro and Tolhurst will represent our Research Network in the Forum for PhD students/early career sociologists of the European Sociological Association. Second, we decided to organize our first spring school for PhD students in 2015. This spring school will have a more extensive programme than the workshops for PhD students that we previously organized.

The Spring school of the Research on Aging Network has been titled **Long live the active!?**A critical perspective on active ageing. It will take place on the 23-25 March, 2015 at the University of Duisburg-Essen, Germany. Organisers of the spring school are Dirk Hofaeck-

er, University Duisburg-Essen, Germany, and Marja Aartsen, Vrije Universiteit Amsterdam, The Netherlands.

During the meeting we will bring together PhD students, early career scientists and senior researchers from various scientific disciplines with an interest on aging research to discuss different aspects of active aging at macro (politics), meso and micro (individual) level. Sessions will be organized around five themes: retirement, social policy and demographics, definitions of active aging, resilience and a critical perspective on aging.

In addition to those two projects, PhD students are of course also welcome to participate in our mid-term conference, which will take place this fall in Klagenfurt, Austria. We are already looking forward to seeing many of you at this conference! # Call for papers: Conference on "Ageing, Anti Ageing & Ageism: Constructions and Politics of Being Old in Europe"

2014 Mid-term conference of the Research Network on Ageing in Europe, European Sociological Association (ESA), Carinthia University of Applied Science, Klagenfurt, Austria, 18-20 September 2014

Managing the processes of ageing, both at individual and at societal levels, is seen as a main challenge for the future in many European societies. On the one hand, the ageing of societies is frequently discussed as a major cause for economic and social crises (e.g., for welfare states and families). On the other hand, longevity is debated as a challenge for the performance in relation to social, cultural and professional societal expectations. There is less discussion, however, on the meaning of ageing itself. Questions are arising whether the analysis of current developments relies on, reproduces or challenges current understandings of "being old" (Butler 1975): What is the interconnection between scientific, public and cultural conceptualisations of age and ageing? How can societal images and dynamics such as "anti-ageing" and "ageism" be explained? What consequences do positive approaches and discourses, such as active or successful ageing, have for those who are not easily classified as "productive" or "active"? How do welfare states react to changing notions of old age and ageing? What are options and consequences for both sociology and social work? This conference brings together scholars from across Europe to discuss developments in ageing and old age.

Such developments could include, but are not limited to:

- Ageing and work, older workers, retirement, and pensions;
- Ageism in political, social and cultural contexts;
- Concepts of anti-aging vs. longevity;
- Formal and informal care arrangements;
- Intergenerational relationships;

- Critical assessments of active and productive ageing;
- Social inequalities and poverty in old age;
- Effect of population ageing on generational solidarity and welfare states;
- Images, attitudes, coping-strategies and ageing;
- Development of social work for the elders in Europe.

We welcome theoretical, quantitative, qualitative and conceptual papers.

Contributions from scholars in the early stages of their careers are very welcome.

Confirmed Keynote speakers are Martin Kohli and Julia Twigg. Further information will follow soon!

Special sessions with a particular regional focus – such as on Ageing in Sub-Saharan Africa, and on elder-care in the AlpeAdriaRegion in comparison to other European (especially rural) areas – are planned to widen the scope for research and cooperation. Additionally an interdisciplinary plenary discussion on informed consent and social supported palliative care are anticipated. Contributions to these – or proposals for additional – special sessions are highly welcome.

Please submit your abstract of max. 200 words until 5th of April 2014 to abstracts@ageing-ineurope.org. The preliminary program will be published on our homepage – finally – on 25th of May 2014.

The regular conference fee is 150 Euro for Students, 290 Euro for Professionals. The early bird fee (May 15th to June 25th) is 85 Euro for Students, 185 Euro for Professionals.

Members of the Research Network on Ageing in Europe receive a reduced fee of 155 Euro (Students 70 Euro). The fee includes the conference material, a welcome reception, the conference dinner, and refreshments on all three days.

The world is aging, and Europe is the oldest of all continents. The increase in life expectancy is one of the biggest victories of science. It challenges policymakers and professionals to find innovative ways to stimulate autonomy, well - being and active involvement in society of all citizens by integrating the latest insights of scientific research on aging. The Faculty of Social Sciences and the VU Medical Center conduct a large ongoing study on aging which provides ample opportunities to inform students with up-to-date insights in gerontology.

During the first week of the course, students will get a thorough understanding of the social and psychological functioning of older people. Main theories in social and psycho-

gerontology will be addressed and applied to actual social problems of the aging population, including

social networks, volunteering, informal care, loneliness, life styles and memory functioning, and successful aging.

Age and ageing are not only biological events but also cultural and social constructions. The ways in which individuals and the societies they live in construe and portray age and ageing are interesting not only from a theoretical point of view (from whichever discipline one may be looking at them) but also, crucially, for the very practical impacts in dealing with and understanding an ageing population. From the drafting of legislation to the provision of social services and care; from welfare reform to intergenerational relations, the ways in which we, as individuals and as a society, portray and understand age and

# Nordic Seniors on the Move. Mobility and Migration in Later Life.


Editors: Anne Leonora Blaakilde (University of Copenhagen) & Gabriella Nilsson (Lund University).

The book contains studies on:

- Swedish seniors who move to the countryside, to Costa del Sol, attend the Swedish Church abroad, construct homeliness, and do voluntary work. While on the move, they do not "feel old".
- Finnish seniors who move to Costa del Sol, change their eating habits and attend Nordic Churches
- Danish retirees who move to Spain and Turkey to manage their own health, but do not get an equal support from the Danish state, compared to other retirees in Denmark.
- And global tendencies of retirement migration; i.e. in US, where some seniors live in ghettoes and create certain senior urban spaces.

# It's a scandal! Comparing the causes and consequences of nursing home media scandals in five countries.

This study explores the causes and consequences of media scandals involving nursing homes for older persons in Canada, Norway, Sweden, the United Kingdom and the United States. Design/methodology/approach - This study uses a descriptive case study methodology which provides an in-depth, focused, qualitative analysis of one selected nursing home scandal in each jurisdiction. Scandals were selected on the basis of being substantive enough to potentially affect policy. An international comparative perspective was adopted to consider whether and how different social, political and economic contexts might shape scandals and their consequences. Findings - This study found that for-profit residential care provision as well as international trends in the ownership and financing of nursing homes were factors in the emergence of all media scandals, as was investigative reporting and a

lack of consensus around the role of the state in the delivery of residential care. All scandals resulted in government action but such action generally avoided addressing underlying structural conditions. Research limitations/implications - This study examines only the short-term effects of five media scandals. Practical implications -Originality/value - While there has been longstanding recognition of the importance of scandals to the development of residential care policy, there have been few studies that have systematically examined the causes and consequences of such scandals. This paper contributes to a research agenda that more fully considers the media's role in the development of residential care policy, attending to both its promises and shortcomings.

The University of Brighton is announcing 16 studentships, one of which directly pertains to LGBTQ Lives with a possible focus on ageing.

We are offering the opportunity for a doctoral student to develop an innovative project that relates to understandings of contemporary queer lives by exploring interactions within LGBT populations and/or between LGBT and non-LGBT populations and how these relate to areas such as identity formation, community engagement/affiliation, minority political practices, and their implications for health and psychological well-being.

The project will be located in the School of Applied Social Science and the candidate will have links with the university-wide Lesbian, Gay, Bisexual, Trans and Queer Life Research Hub. The proposed research project should seek to explore sexual and gender exclusions and liberations through interactions and

encounters between sexual/gender others and 'mainstream' societies.

The proposed research should aim to improve understandings of LGBT/Q experiences often formed in the context of marginalisation, exclusion and stigmatisation. It is expected that the project will be informed by transdisciplinary theories developed in feminist, queer, affect, sexualities, critical psychological/psychosocial, sociological and cultural geography studies. The project is also expected to provide empirical evidence and offer significant methodological innovation by drawing on qualitative, visual and participatory-community approaches.

## Research Fellow in Aging and Later Life

National Institute for the Study of Ageing and Later Life (NISAL), Linköping University, Sweden

Very good knowledge of English, and a strong ambition for further qualification is of merit.

The holder of the appointment shall show documented skills in teaching in the area of ageing and later life. Documented skills in teaching on ageing, later life, life-course and quantitative methodology with relevance to this area gives merits.

# University of Salford launches Institute for Dementia

On Monday 9 December 2013 the University of Salford launched a ground-breaking research institute dedicated to improving the lives of people living with dementia.

The UK's ageing population and growing numbers of people with dementia have prompted the creation of the Salford Institute for Dementia to channel the University's expertise into enabling people to stay independent for longer while minimising distress and discomfort to themselves, their carers and family and friends.

The Institute will bring together academics from across the University to investigate how the disciplines of health and social care, the built environment, product design, virtual reality, robotics and media and the arts can work together to improve the dignity, independence and quality of life of people with dementia.

One of the ways the Institute will contribute to dementia research is by exploring the potential uses of technology, and software is being developed which will use virtual reality to evoke memories and emotional responses. At the early stages of dementia, people could be filmed talking to and embracing a loved one. When their memory fades they will be able to experience the moment again in a 3D

Design will also be used to help people living with dementia by creating environments that support everyday living in settings such as hospital wards, homes and gardens with the aim of maximising independence and reducing frustration.

A donation from the Medlock Charitable Trust has supported the launch of the Institute.

### Senior Capital – Future is built on your experience

European countries increasingly face the challenge of ageing in different fields. This also affects the labour market. The project *Senior Capital* aims at contributing to the economic competitiveness of Central Europe through developing knowledge and enlarging the quality work force with a focus on mature employees.

Senior Capital has started in September 2012 and ends in December 2014. Within this project nine partners from Hungary, Slovenia,

Italy, Poland, Austria and Germany cooperate transnationally. To begin with the situation of elderly employees in the partners' regions was analysed, a best-practice collection has been compiled and an analysis of the European framework been carried now. Currently tailor made pilot actions are implemented by each partner that focus on different aspects of mature workers in the labour market as well as capturing knowledge and competencies after the end of the professional career.

Existing education and employment models as well as framework conditions are analysed, new, selected models covering the full cycle of career paths are tested and awareness raising actions are implemented. Local action plans

will be developed towards the end of the project with stakeholder participation.
